Appointment Process to City Boards and Commissions

There are approximately 30 volunteer appointed [boards and commissions](#) in Stamford, with a total of just over 150 members. These do not include the Board of Education, Board of Finance and Board of Representatives, which are all elected. If you are interested in applying to serve on a board or commission, please review the steps listed below. Please note that this is the most common process for most of the boards and commissions, though there are a few that do not go through this process per the city charter.

1. Submit application – the initial step for anyone who wishes to serve on a board or commission is filing out an application. The application can be found on the City of Stamford website [here](#) and once submitted (along with a current resume) will be automatically shared with the Mayor’s Office. You must be a Stamford resident to serve.
2. There are majority/minority party representation requirements for boards and commissions, ex. a five-person board can have no more than three individuals of any one political party. A small number of positions are ex-officio, meaning they are reserved for city officials of varying types. There are some board positions, but not many, that require specific professional expertise.
3. Several boards have alternate members who fill in for members if they are not available at a meeting. The appointments process for an alternate position is the same.
4. By long-standing practice, interested individuals who are members of the Democratic Party are approved by the Democratic City Committee (DCC) and members of the Republican Party are approved by the Republican Town Committee (RTC). People who are registered as Unaffiliated, or with a minority party, are also eligible to serve and may be interviewed by the [Appointments Commission](#).
5. For Democratic applicants, the appointments process includes submitting a resume, interviewing with the DCC Appointments Subcommittee, and receiving an affirmative vote by the full Democratic City Committee before moving forward in the process.
6. All applicants are interviewed by the Mayor’s Office. Once the applicant is approved by the Mayor, the Mayor may submit the applicant’s name to the Board of Representatives (BOR) for final approval. The Board of Representatives Appointments Committee interviews applicants and then the full Board of Representatives votes on the applicant at their monthly meeting (see [link](#) to the BOR Appointments Committee for more information).
7. Most board or commission appointments are for a three-year term. When the term expires, the member stays on the board or commission until they are reappointed, replaced, or resign.

Recordings of board and commission meetings, as well as agendas and minutes, are on the City of Stamford [website](#). Please take time to review them before applying and interviewing.

<p>Arts & Culture The Stamford Arts & Culture Commission is charged with stimulating, facilitating, coordinating, and cooperating with Stamford's arts and cultural organizations for the development of the creative, performing, and visual arts. <p>Board of Assessment Appeals The Board of Assessment Appeals is an official municipal agency. It is designed to serve as an appeal body for taxpayers who believe that town or city assessors erred in the valuation of their properties or erroneously denied them exemptions. The Board enables taxpayers to be heard by their peers at no expense. No fees are charged for the appeal process. Furthermore, taxpayers do not have to be represented by counsel.</p>	5	3 yrs. <p>Board of Ethics The Board of Ethics has the responsibility of investigating any complaints of violation of the Stamford Code of Ethics by an officer or employee of the City government. Officers include elected and appointed officials. In addition, the Board, when requested, issues Advisory Opinions to officers or employees of the City who seek guidance about their contemplated actions which might be considered a violation of the Code.</p>	7/2 alts	5 yrs. <p>Economic Development Commission The Economic Development Commission is an advisory board that conducts research into the economic conditions and trends in Stamford. The commission makes recommendations to appropriate officials and agencies in Stamford city government regarding action to improve the economic condition and development of the City. It renders written opinions on the economic impact and advisability of any decision to be made on any matter pending before any board, commission, agency, department, or member of the executive branch, but only after requested by the decisionmaker on that particular matter, the Board of Representatives or the Mayor.</p>	5	3 yrs. <p>Harbor Management The Stamford Harbor Management Commission regulates and monitors shoreline development and reviews and makes recommendations to various land use boards on issues within their area of jurisdiction. <p>Health Commission The Health Commission function is advisory to the Health Director in formulating health policies for the City. <p>Historic Preservation Advisory Commission (HPAC) The role of HPAC is to advise officials, boards, commissions and departments of the City of Stamford regarding the protection of local cultural resources; recommend properties and sites for the designation of historic districts or landmarks; liaise on behalf of City of Stamford with individuals and organizations concerned with historic preservation; and advise on the design of structures, improvements and cultural resources in the city's historic districts, as well as those adjacent to historic properties. <p>Parking Violation Hearing Board Hear appeals of parking violations and either uphold or deny the appeals. They do not meet as a board but hear the appeals as individual officers. <p>Patriotic & Special Events Commission the Patriotic and Special Events Commission is authorized to arrange for all patriotic and special events for which the City provides funds or otherwise participates, such as observances of patriotic and other holiday celebrations. <p>Planning Board The Planning Board is responsible for planning and coordinating the development of the City. The Board has two main tools to plan for the City's future. The Master Plan is a vision, policy and implementation plan that guides the City forward. Based on the analysis of existing conditions and anticipated needs, it is a comprehensive plan that addresses economic development, transportation and mobility sustainability and other issues. The second tool the Planning Board has available is the Capital Budget . The Capital Budget lays out the City's investments in streets, schools, parks and other infrastructure and facilities. The Planning Board drafts the Capital Budget which is then reviewed and approved by the Mayor, the Board of Finance and the Board of Representatives. Other responsibilities include maintaining the City's official map, reviewing subdivision applications, and hearing and making recommendations on most zoning board and zoning board of appeals applications.</p>	5/3 alts	3 yrs. <p>Social Services Commission The Social Service Commission deals with social welfare concerns facing the residents of Stamford including, but not limited to programs which address shelter, sustenance, and health needs. It promotes coordination between those city departments concerned with social welfare, including the Board of Education, and nonprofit organizations. <p>Urban Redevelopment Commission (URC) The URC is authorized to prepare and/or approve plans for urban redevelopment and urban renewal projects, as well as certain other projects. Those plans must be approved by several City Boards, and ultimately by the Board of Finance and the Board of Representatives in order to become effective. <p>Water Pollution Control Authority (WPCA) The WPCA manages and maintains the City water treatment plant. <p>Zoning Board The Zoning Board plays a critical role in shaping the city. It regulates the height, bulk and uses of property based on Stamford's Zoning Regulations. The Zoning Board reviews applications for changes to the Zoning Map, Zoning Text, Special Exceptions, Site and Architectural Plans and Coastal Site Plans. The board conducts public hearings and administrative review of applications based on rules defined in the City Charter.</p>	5/3 alts	3 yrs. <p>Zoning Board of Appeals The Zoning Board of Appeals considers variances of the zoning regulations where there is an unusual hardship.
